



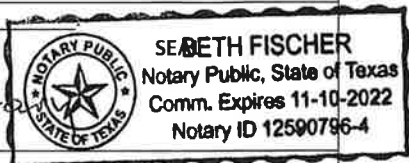
Before me, the undersigned authority, on this day personally appeared (name) JAMES A. Wilson, who being by me here and now duly sworn, upon oath says:


