3. Phone calls are up by about 200 for the month
4. Animal Hope is bringing in a cat condo to the ACO to assist with the adoptions of cats and kittens. All the animals brought in by Animal Hope will be vetted at Animal Hopes expense.
5. Dr. Daniels requested to schedule an inspection at the ACO building. A date was not determined but will be conducting in the next couple of weeks.
