**Plat Filing Date:** A monthly date the Planning and Zoning Commission accepts a copy of a plat for filing.

**P&Z Meeting:** The dates throughout the year the Planning and Zoning Commission hold their monthly meetings; the 2<sup>nd</sup> Thursday of every month. The Commission will approve, approve with conditions, or disapprove a plat within the 30 days from when it is filed with the Commission.

The Commission will approve or disapprove a plat which was previously conditionally approved or disapproved, within 15 days of resubmission to the Commission.
