

BUILDING PERMIT FEES

NON-RESIDENTIAL / MULTI-FAMILY

CONSTRUCTION VALUE*	PERMIT FEE
\$1 - \$500	\$23.50
\$501 - \$2,000	\$23.50 for the first \$500.00 + \$3.05 for each additional \$100 or fraction thereof to and including \$2,000
\$2,001 - \$25,000	\$69.25 for the first \$2,000 + \$14.00 for each additional \$1,000 or fraction thereof to and including \$25,000
\$25,001 - \$50,000	\$391.75 for the first \$25,000 + \$10.10 for each additional \$1,000 or fraction thereof to and including \$50,000
\$50,001 - \$100,000	\$643.75 for the first \$50,000 + \$7.00 for each additional \$1,000 or fraction thereof to and including \$100,000
\$100,001 - \$500,000	\$993.75 for the first \$100,000 + \$5.60 for each additional \$1,000 or fraction thereof to and including \$500,000
\$500,001 - \$1,000,000	\$3,233.75 for the first \$500,000 + \$4.75 for each additional \$1,000 or fraction thereof to and including \$1,000,000
\$1,000,001 and up	\$5,608.75 for the first \$1,000,000 + 3.65 for each additional \$1,000 or fraction thereof

PLAN REVIEW FEE is due at the time of submittal and the cost is 25% of the Building Permit Fee.

***VALUE** is established by the most recently adopted ICC Building Valuation Chart or value submitted by the applicant, whichever is greater. For shell construction, use 80% of table value; for interior finish-out and remodel, use 40% of table value.

SINGLE FAMILY RESIDENTIAL \$0.85 per square foot - \$50 min.

THE BUILDING PERMIT is issued to the general contractor. All mechanical, electrical, and plumbing fees are charged in addition to the building permit (separate permits are not required).

MECHANICAL, ELECTRICAL, PLUMBING (MEP) FEES (each)

Associated with a Building Project - \$50 min.

Plumbing	\$0.05 per square foot
Electrical	\$0.05 per square foot
Mechanical	\$0.05 per square foot

SUPPLEMENTAL PLAN REVIEW FEE is \$50/hour (min 2 hrs.). Only assessed after original set of plans have been reviewed and approved for construction and changes are made.

WORK DONE WITHOUT A PERMIT normal fee may be doubled.

CONTRACTOR REGISTRATION FEE

Initial Registration	\$100 per trade
Annual Renewal	\$50

Exceptions to this are homeowners acting as their own General Contractor. Proof of liability insurance is required to register.
